

**PENNSYLVANIA STATE ATHLETIC CONFERENCE
BASKETBALL SPORTS OFFICIATING AGREEMENT**

CONDITIONS OF AGREEMENT

1. I agree to serve as an independent contractor, and not as an employee of the Pennsylvania State Athletic Conference (PSAC) or any of its institutions.
2. I agree that, as an independent contractor, it is my own personal responsibility to ensure that I have met proper medical and physical examinations and proper medical clearance for my accepted assignments.
3. I agree that, as an independent contractor, I am not covered by workmen's compensation or any other insurance policy held by the PSAC or its member institutions.
4. I agree that, as an independent contractor, it is my own personal responsibility to ensure that I have the appropriate personal insurance to cover an and all liability and/or expenses and/or loss of wages that may occur as a result of injury or damage sustained to me and/ or others while fulfilling the accepted assignment(s) and/ or traveling to and from the accepted assignment(s).
5. I agree, that as an independent contractor, I am not an employee of the PSAC or its member institutions and that no withholdings will be deducted from my fee: however, my fee may be reported by the institution for whom I may officiate on a Form 1099 or other appropriate Internal Revenue Service Form, so I may be earning reportable income.
6. I agree to hold the Pennsylvania State Athletic Conference, its commissioner, officiating assignor, and member institutions, harmless from any and all liability for injury or damage sustained as a result of any assignment(s).
7. I agree to attend all required officiating meetings, camps and clinics as required by my respective officiating assignor. Additionally I agree and designate the PSAC as my primary Sub-Division I conference and if assigned accept PSAC assignment/s.
8. I agree that the "host team" institution will be responsible for my game fee, which will be paid prior to the start of the contests. The "host team" will make every effort to ensure that my fee is paid prior to the contest; however, in some instances, the required paperwork makes it difficult.
9. I agree to officiate impartially and solely in accordance with the rules of play. Additionally, I agree to arrive at the site of each assignment at the prescribed time for each respective sport.
10. I agree to complete and return to my respective officiating assignor, or the PSAC office, any required written reports, evaluation forms and Arbitration revisions/additions and notifications related to the accepted assignment(s).
11. I agree that any assignment(s) is subject to reassignment or cancellation by the PSAC or the respective officiating assignor when and if he/she, in his/her judgment, deems such reassignment or cancellation to be in the best interest of the conference.

ACCEPTANCE OF CONDITIONS AND ASSIGNMENTS: By my signature below, I agree to all of the rules set forth in the above agreement and accept membership as an official with the Pennsylvania State Athletic Conference. I agree to abide by all the rules. I will conduct myself in a professional manner at all times. I will arrive on time for all my assignments. I understand I am not covered by any insurance or Workmen's Compensation.
